

## 1099G表格

## 什麼是1099G表格？

1099G表格是加利福尼亞州就業發展部(EDD)在一個日曆年內向您出具的應納稅總收入的記錄,該表格會報至IRS。

如果您從EDD領取失業救濟金(UC),您將收到1099G表格,並且必須將該救濟金作為收入在您的聯邦報稅表中進行申報。UC免徵加利福尼亞州所得稅。

應納稅UC包括:

- 作為UI福利的替代品而獲得的殘障保險(DI)福利
- 災難失業援助(DUA)福利
- 帶薪家庭假(PFL)福利
- 大流行失業補助(PUA)福利
- 失業保險(UI)福利,包括:
  - 聯邦延長救濟(FED-ED)
  - 工資損失援助(LWA)
  - 大流行緊急失業救濟金(PEUC)
  - 大流行額外救濟金(PAC)

## 何時能獲得1099G表格？

由於申請失業救濟的人數極高,IRS允許EDD在2月份前處理1099G表格。如果您在2020年表格上看到\$0的金額,請致電1-866-401-2849。\*

如果您沒有通過電子郵件註冊,您將通過信函收到紙質表格。可在[UI Online](#)獲取1099G表格稅務信息,有效期最長為五年。

如果您的1099G表格有任何調整,則該表格將不會在線顯示。如需諮詢事務代表,請致電1-866-401-2849。\*

## 如何索取我的1099G表格副本？

1099G表格稅務信息最長可在五年內獲取。若要在線訪問副本或索取紙質副本,請執行以下操作:

1. 登錄 [Benefit Programs Online](#).
2. 選擇 **UI Online**.
3. 選擇 **Form 1099G > View** 選擇需要查看的年份 > **Print** 或 **Request Paper Copy**.

The federal EITC is a refundable federal income tax credit available to low to moderate income working individuals and families. The EITC has no effect on eligibility for Medicaid, Supplemental Security Income, food stamps, or most other temporary assistance for those in need. Even if you do not owe federal taxes, you must file a tax return to receive the EITC.
