## REQUEST FOR ELIGIBILITY INFORMATION DUE TO FAILURE TO ATTEND A MANDATORY APPOINTMENT

In order to be eligible for federal Emergency Unemployment Compensation (EUC) benefits, you must attend all interviews and/or workshops that the Department schedules for you to assist you in returning to work. You were scheduled for a <u>mandatory</u> EUC Reemployment Eligibility and Assessment (REA) appointment on You did not attend your scheduled REA EUC appointment. The reason you did not attend may affect your eligibility for benefits.

You must provide the reason why you did not attend the scheduled REA EUC appointment by answering the questions on **page 2** and completing **pages 3 and 4**. If you were working or had a job interview on the day of the REA EUC appointment, check box number **1 on page 2** of this questionnaire and provide all the requested information. If you were not working or attending a job interview, check box number **2 on page 2** and provide a complete explanation of the reason you did not attend the REA EUC appointment. Attach additional pages, if necessary, to provide a full explanation and always include your Social Security Number on each additional page. **The information you provide on pages 2 through 4 will be used to determine whether you are eligible to be paid EUC benefits.** 

If the Department determines you had good cause for not participating in your mandatory scheduled REA EUC appointment, you still must report for a REA EUC interview in order to meet the ongoing EUC program eligibility requirements. You should report to the One-Stop Career Center listed on the original appointment notice with the completed *Reemployment and Eligibility Assessment Questionnaire*, DE 8531 as soon as possible to minimize the number of weeks of potential disqualification of benefits. If you no longer have your original appointment notice with the One-Stop Career Center address, you can contact the Unemployment Insurance program through the EDD website at <u>www.edd.ca.gov</u> and send an online request for the address by selecting the "Contact EDD" link at the top of the Web page and then selecting the "Ask EDD" link. You can also call the EDD at one of the toll-free telephone numbers listed on this notice.

To help you review the steps that you must complete in advance of participating in a REA EUC interview, including obtaining a copy of the Reemployment and Eligibility Assessment Questionnaire, go to the website at <u>www.edd.ca.gov/unemployment</u>, and on the right column under "Important Links," select "Reemployment and Eligibility Assessment 2012." The REA Questionnaire is located at the bottom of the Web page under "General Information and Related Publications." You can complete the form online, print a copy, and bring it to your interview.

**Reminder:** To remain eligible for extended benefits, you must have an active CalJOBS<sup>SM</sup> registration which includes a current online résumé. You may register or update your résumé by accessing the EDD online at <u>www.caljobs.ca.gov</u>.
